RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SNYDER. TEXAS. APPROVING A NEGOTIATED SETTLEMENT BETWEEN THE ATMOS CITIES STEERING COMMITTEE ("ACSC") AND ATMOS ENERGY CORP., MID-TEX DIVISION REGARDING THE COMPANY'S 2017 RATE REVIEW MECHANISM FILINGS; DECLARING EXISTING RATES TO BE UNREASONABLE; ADOPTING TARIFFS THAT REFLECT RATE ADJUSTMENTS CONSISTENT WITH THE NEGOTIATED SETTLEMENT; FINDING THE RATES TO BE SET BY THE SETTLEMENT TARIFFS TO BE JUST AND REASONABLE AND IN THE PUBLIC INTEREST; REQUIRING RECONCILIATION AND RATE FEDERAL ADJUSTMENTS IF INCOME TAX RATES CHANGE: TERMINATING THE RRM PROCESS FOR 2018 PENDING RENEGOTIATION OF RRM TERMS AND CONDITIONS; REQUIRING THE COMPANY TO REIMBURSE ACSC'S **REASONABLE** RATEMAKING **EXPENSES**; DETERMINING THAT THIS RESOLUTION WAS PASSED IN ACCORDANCE WITH THE REQUIREMENTS OF THE TEXAS OPEN MEETINGS ACT; ADOPTING A SAVINGS CLAUSE; DECLARING AN EFFECTIVE DATE; AND REQUIRING DELIVERY OF THIS RESOLUTION TO THE COMPANY AND THE ACSC'S LEGAL COUNSEL.

WHEREAS, the City of Snyder, Texas ("City") is a gas utility customer of Atmos Energy Corp., Mid-Tex Division ("Atmos Mid-Tex" or "Company"), and a regulatory authority with an interest in the rates and charges of Atmos Mid-Tex; and

WHEREAS, the City is a member of the Atmos Cities Steering Committee ("ACSC"), a coalition of similarly-situated cities served by Atmos Mid-Tex ("ACSC Cities") that have joined together to facilitate the review of, and response to, natural gas issues affecting rates charged in the Atmos Mid-Tex service area; and

WHEREAS, ACSC and the Company worked collaboratively to develop a new Rate Review Mechanism ("RRM") tariff that allows for an expedited rate review process by ACSC Cities as a substitute to the Gas Reliability Infrastructure Program ("GRIP") process instituted by the Legislature, and that will establish rates for the ACSC Cities based on the system-wide cost of serving the Atmos Mid-Tex Division; and

WHEREAS, on March 1, 2017, Atmos Mid-Tex filed its 2017 RRM rate request with ACSC Cities; and WHEREAS, ACSC coordinated its review of the Atmos Mid-Tex 2017 RRM filing through its Executive Committee, assisted by ACSC's attorneys and consultants, to resolve issues identified in the Company's RRM filing; and

WHEREAS, the Executive Committee, as well as ACSC's counsel and consultants, recommend that ACSC Cities approve an increase in base rates for Atmos Mid-Tex of \$48 million on a system-wide basis; and

WHEREAS, the attached tariffs implementing new rates are consistent with the recommendation of the ACSC Executive Committee, are agreed to by the Company, and are just, reasonable, and in the public interest;

WHEREAS, the RRM Tariff contemplates reimbursement of ACSC's reasonable expenses associated with RRM applications;

WHEREAS, the Company and ACSC have agreed that rates should be adjusted if any change in federal income tax rates is implemented during the period that rates approved herein remain in place; and

WHEREAS, because ACSC believes that certain provisions of the current terms and conditions of the RRM tariff are inconsistent with market conditions, the City expects renegotiation of the current RRM tariff in the Summer of 2017.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SNYDER, TEXAS:

Section 1. That the findings set forth in this Resolution are hereby in all things approved.

Section 2. That the City Council finds that the settled amount of an increase in revenues of \$48 million on a system-wide basis represents a comprehensive settlement of gas utility rate issues affecting the rates, operations, and services offered by Atmos Mid-Tex within the municipal limits arising from Atmos Mid-Tex's 2017 RRM filing, is in the public interest, and is consistent with the City's authority under Section 103.001 of the Texas Utilities Code.

Section 3. That the existing rates for natural gas service provided by Atmos Mid-Tex are unreasonable. The new tariffs attached hereto and incorporated herein as Attachment A, are just and reasonable, and are designed to allow Atmos Mid-Tex to recover annually an additional \$48 million in revenue over the amount allowed under currently approved rates, as shown in the Proof of Revenues attached hereto and incorporated herein as Attachment B; such tariffs are hereby adopted.

Section 4. That the ratemaking treatment for pensions and other post-employment benefits in Atmos Mid-Tex's next RRM filing shall be as set forth on Attachment C, attached hereto and incorporated herein.

Section 5. Consistent with Texas Utilities Code Section 104.055(c), Atmos Energy's recovery of federal income tax expense through the Rider RRM has been computed using the statutory income tax rate. In the event that a change in the statutory income tax rate is implemented during the Rider RRM Rate Effective Date, Atmos Energy shall reconcile the difference between the amount of federal income tax expense included in the Rider RRM calculation for the Rate Effective Date with the amount of federal income tax expense authorized under the new

statutory income tax rate. The reconciliation period shall be from the date on which any new statutory income tax rate is implemented through the Rate Effective Date. An interest component calculated at the customer deposit interest rate then in effect as approved by the Railroad Commission of Texas shall be applied to the federal income tax expense reconciliation. Further, any required reconciliation of federal income tax expense shall be included as part of Atmos Mid-Tex's next annual RRM filing and shall be returned to or recovered from customers as a one-time credit or surcharge to the customer's bill.

Section 6. The City requires renegotiation of RRM tariff terms and conditions during the Summer of 2017. If an agreed renegotiated RRM tariff cannot be achieved, the City will terminate the RRM process and consider initiation of a traditional rate case to reduce the Company's authorized return on equity.

Section 7. That Atmos Mid-Tex shall reimburse the reasonable ratemaking expenses of the ACSC in processing the Company's 2017 RRM filing.

Section 8. That to the extent any resolution or ordinance previously adopted by the Council is inconsistent with this Resolution, it is hereby repealed.

Section 9. That the meeting at which this Resolution was approved was in all things conducted in strict compliance with the Texas Open Meetings Act, Texas Government Code, Chapter 551.

Section 10. That if any one or more sections or clauses of this Resolution is adjudged to be unconstitutional or invalid, such judgment shall not affect, impair, or invalidate the remaining provisions of this Resolution, and the remaining provisions of the Resolution shall be interpreted as if the offending section or clause never existed.

Section 11. That consistent with the City Ordinance that established the RRM process, this Resolution shall become effective from and after its passage with rates authorized by attached tariffs to be effective for bills rendered on or after June 1, 2017.

Section 12. MODEL STAFF REPORT

The City, along with other similarly situated cities served by Atmos Energy Corp., Mid-Tex Division ("Atmos Mid-Tex" or "Company"), is a member of the Atmos Cities Steering Committee ("ACSC"). The RRM Tariff was originally adopted by ACSC member cities in 2007 as an alternative to the Gas Reliability Infrastructure Program ("GRIP"), the statutory provision that allows Atmos to bypass the City's rate regulatory authority to increase its rates annually to recover capital investments. The RRM Tariff has been modified several times, most recently in 2013.

The 2017 RRM filing is the fifth RRM filing under the renewed RRM Tariff. On March 1, 2017, Atmos made a filing requesting \$57.4 million additional revenues on a system-wide basis. Because the City of Dallas has a separate rate review process, exclusion of Dallas results in the Company requesting \$46.4 million from other municipalities.

Environs customers (ratepayers outside municipal limits) remain under the Railroad Commission's exclusive original jurisdiction and have their rates set through the GRIP process. If the Company had used the GRIP process rather than the RRM process it would receive a \$52.4 million increase, or about \$4.4 million more than will be approved by the Ordinance. ACSC and the Company have reached an agreement, reflected in the Ordinance, to reduce the Company's request by \$9.4 million, such that the Ordinance approving new rates reflects an increase of \$48 million on a system-wide basis, or \$38.8 million for Mid-Tex Cities, exclusive of the City of Dallas.

The tariffs attached to the Ordinance approve rates that will increase the Company's revenues by \$38.8 million for the Mid-Tex Rate Division, effective for bills rendered on or after June 1, 2017. The monthly residential customer charge will be \$19.60. The consumption charge will be \$0.14 per Ccf. The monthly bill impact for the typical residential customer consuming 46.8 Ccf will be an increase of \$2.04, or about 3.87%. The typical commercial customer will see an increase of \$6.27, or 2.37%. Attached to this Model Staff Report is a summary of the impact of new rates on the average bills of all customer classes.

The ACSC Executive Committee and its designated legal counsel and consultants recommend that all Cities adopt the Ordinance with its attachments approving the negotiated rate settlement resolving the 2017 RRM filing, and implementing the rate change.

Explanation of "Be It Ordained" Sections:

- 1. This section approves all findings in the Ordinance.
- 2. This section finds the settled amount of \$48 million on a system-wide basis to be a comprehensive settlement of gas utility rate issues arising from Atmos Mid-Tex's 2017 RRM filing, and that such settlement is in the public interest and is consistent with the City's statutory authority.
- 3. This section finds the existing Atmos Mid-Tex rates to be unreasonable, and approves the new tariffed rates providing for additional revenues over currently-billed rates of \$48 million on a system-wide basis and adopts the attached new rate tariffs (Attachment A).

- 4. This section establishes the baseline for pensions and other post-employment benefits for future rate cases (Attachment C).
- 5. This section requires the Company to reimburse Cities for reasonable ratemaking costs associated with reviewing and processing the RRM filing.
- 6. This section requires a rate reconciliation in the event that federal income tax rates change.
- 7. This section requires renegotiation of current RRM terms and conditions this Summer and if new terms and conditions are not agreed to by both parties, the RRM process will be terminated and Cities will be encouraged to pass show cause resolutions to trigger a traditional rate case at the Railroad Commission.
- 8. This section repeals any resolution or ordinance that is inconsistent with this Ordinance.
- 9. This section finds that the meeting was conducted in compliance with the Texas Open Meetings Act, Texas Government Code, Chapter 551.
- 10. This section is a savings clause, which provides that if any section(s) is later found to be unconstitutional or invalid, that finding shall not affect, impair or invalidate the remaining provisions of this Ordinance. This section further directs that the remaining provisions of the Ordinance are to be interpreted as if the offending section or clause never existed.
- 11. This section provides for an effective date upon passage which, according to the Cities' ordinance that adopted the RRM process, is June 1, 2017.
- 12. This paragraph directs that a copy of the signed Ordinance be sent to a representative of the Company and legal counsel for the Steering Committee.

STAFF REPORT ON ASSESSMENT RESOLUTION FOR ATMOS CITIES STEERING COMMITTEE

Purpose of the Resolution:

Most municipalities have retained original jurisdiction over gas utility rates and services within municipal limits. The Atmos Cities Steering Committee ("ACSC") is composed of municipalities in the service area of Atmos Energy Corporation, Mid-Tex Division regardless of whether original jurisdiction has been retained. Atmos is a monopoly provider of natural gas. Because Atmos has no competitors, regulation of the rates that it charges its customers is the only way that cities can ensure that natural gas rates are fair. Working as a coalition to review the rates charged by Atmos allows cities to accomplish more collectively than each city could do acting alone. Cities have more than 100 years experience in regulating natural gas rates in Texas.

ACSC is the largest coalition of cities served by Atmos Mid-Tex. There are 168 ACSC member cities, which represent more than 60 percent of the total load served by Atmos-Mid Tex. ACSC protects the authority of municipalities over the monopoly natural gas provider and defends the interests of residential and small commercial customers within the cities. Although many of the activities undertaken by ACSC are connected to rate cases (and therefore expenses are reimbursed by the utility), ACSC also undertakes additional activities on behalf of municipalities for which it needs funding support from its members.

The ACSC Membership Assessment Supports Important Activities:

ACSC is actively involved in rate cases, appeals, rulemakings, and legislative efforts impacting the rates charged by Atmos within the City. These activities will continue throughout the calendar year. It is possible that additional efforts will be necessary on new issues that arise during the year, and it is important that ACSC be able to fund its participation on behalf of its member cities. A per capita assessment has historically been used, and is a fair method for the members to bear the burdens associated with the benefits received from that membership.

Explanation of Resolution Paragraphs:

- I. This paragraph authorizes the continuation of the City's membership in ACSC.
- II. This paragraph authorizes payment of the City's assessment to the ACSC in the amount of two cents (\$0.02) per capita.
 - III. This paragraph requires notification that the City has adopted the Resolution.

2016 Year in Review

Upcoming Legislative Agenda

The 85th Texas Legislature will convene on Tuesday January 10th and natural gas utility issues will be a high priority during the session. As in the past, city coalitions including the Steering Committee of Cities Served by Atmos, the Steering Committee of Cities Served by Oncor, and the Texas Coalition for Affordable Power will play an important role in educating legislators on utility issues, advocating for positive utility legislation, and defending against harmful bills.

In particular, city coalitions will oppose auditbased ratemaking proposals, or other piecemeal ratemaking efforts affecting natural gas utilities, as well as bills limiting cities' original jurisdiction over these matters. Protecting the ability of cities and the PUC to fulfill their regulatory functions remains a top issue for cities. Cities will also oppose any legislation that seeks to diminish franchise fee payments for natural gas utilities' use of municipal rights-of-way or bills that would infringe on cities' right to require certain utility relocations.

Additionally, as utility bills continue to be filed in anticipation of the Session commencement, city groups will monitor these and any other utility issues that arise.



Sunset Commission Makes Final RRC Recommendations

In November of 2016, the Sunset Advisory Commission voted on its final recommendations for reforms to the Texas Railroad Commission ("RRC"). The proposed reforms will become the basis for "Sunset" legislation to be taken up during the 85th Texas Legislature this year.

Texas House and Senate lawmakers on the Sunset Advisory Commission accepted a number of Sunset staff recommendations, but removed those pertaining to gas utility ratemaking. Each of the rejected recommendations had been endorsed by city and consumer groups. The rejected reforms included a proposal to change the agency's name to

one that better reflects its responsibilities, a proposal to transfer administrative law cases currently handled by RRC staff to the State Office of Administrative Hearings, and a proposal to transfer gas utility cases to the Public Utility Commission of Texas.

The reforms the Sunset Advisory Commission adopted include recommendations designed to improve the monitoring of the oil and gas industry, to authorize the creation of pipeline permit fees, and to direct the RRC to incorporate findings from a seismic monitoring program into its disposal well guidelines.



Texas Gas Utilities Continue to Consolidate Service Areas

Last year we reported that some gas utilities began a trend of consolidating service areas across the state. Specifically, Texas Gas Services ("TGS") has been seeking RRC approval to combine its service areas throughout the state. Like Atmos, TGS previously maintained separate service areas specific to small geographical regions. However, TGS has been consolidating its particular service areas into larger divisions.

Late in 2015, TGS filed a rate case seeking to increase rates in its Galveston Service Area and South Jefferson County Service Area, as well as consolidating the service areas into a new, single service area called the Gulf Coast Service Area. Despite opposition to unfair rate subsidies from the cities involved, the parties eventually agreed to the consolidation as part of a settlement agreement. TGS made a similar filing in March 2016, requesting to increase rates and consolidate the El Paso Service Area, Dell City Service Area, and Permian Service Area into a single West Texas Service Area. This contested case went to hearing and the RRC ultimately approved the consolidation. Additionally, TGS recently filed to increase rates and consolidate its Central Texas Service Area and South Texas


Service Area into one service area called the Central Texas Consolidated Service Area. The parties settled this case, ultimately agreeing to the consolidation. The Commission recently approved this settlement.

However, the trend to consolidate service areas is now growing beyond TGS. In November 2016, CenterPoint Energy Resources Corp., d/b/a CenterPoint Energy Entex and CenterPoint Energy Texas Gas ("CenterPoint") filed with the RRC a statement of intent to increase gas utility rates within the Houston and Texas Coast Divisions. CenterPoint also seeks to consolidate its Houston and Texas Coast Divisions into a single Texas Gulf Division. Both TGS and CenterPoint claim these consolidations facilitate administrative, regulatory, and operational efficiencies. Parties are just now beginning to litigate the CenterPoint case and city groups will be determining whether one service area will ultimately subsidize another when combined, and whether ratepayers of the consolidated service area will share the benefits of the consolidation. Ultimately. whether to approve this consolidation is up to the RRC, which seems to be in favor of this recent trend of combining service areas.

Wayne Christian Elected Railroad Commissioner

Republican Wayne Christian has won the race for Texas Railroad Commissioner. The former state Representative earned more than 53 percent of the votes, easily beating Democrat Grady Yarbrough. Christian will take the place of Commissioner David Porter, and join Chairman Christie Craddick and Commissioner Ryan Sitton on the three-member Commission.

Christian is currently a financial planner in Center, Texas and was previously in the Legislature for 14 years where he served on the House Energy Committee. During his campaign, Christian said he would not advocate for any major reforms to the RRC during the legislative session and would take a pro-industry position.





Court of Appeals Affirms System-Wide Rates in Atmos West Texas Division

In May, the El Paso Court of Appeals issued an opinion dismissing for lack of jurisdiction the appeal brought by Lubbock and Amarillo of a Railroad Commission Order approving system-wide rates for the Atmos West Texas. This decision is a victory for Atmos West Texas Cities who fought to maintain system-wide rates in the Atmos West Texas Division.

This appeal stems from the 2012 rate case where Atmos requested to increase rates in its West Texas Division on a system-wide basis. Atmos claimed its capital expenditures and operational costs had become so integrated that they no longer could be separated into the three rate jurisdictions — Amarillo, Lubbock, and West Texas Cities — as they had previously. Amarillo and Lubbock opposed the system-wide rates and wanted Atmos to establish gas rates in their separate rate jurisdictions based on the cost of service within their municipal limits. West Texas Cities supported the system-wide rates and, in fact, were instrumental in facilitating Atmos' request to implement them on grounds that

West Texas Cities were unfairly subsidizing the rates of Amarillo and Lubbock, who were being charged lower rates.

Amarillo and Lubbock attempted to litigate the issue of whether system-wide rates were allowed at the RRC, but the hearings examiners precluded it saying it was well-established that the RRC could implement system-wide rates. This appeal ensued despite the parties' partial settlement agreement of the rate case and the Travis County District Court's decision affirming the RRC's actions. Now, four years later, West Texas Cities have yet another court opinion affirming what they have known to be true all along, that system-wide rates were appropriately set in the West Texas Division.

RE: Planning and Zoning Commission Zone Modification Recommendations

The P&Z Commission met to review, discuss and recommend the following changes from the Zoning Ordinance review Panel and related request by individual citizen suggestions.

Provide an exception on property abutting collector streets within the R-1, R-2, and R-3 District to allow request for a zone change to a limited C-1 commercial development.

Allow a maximum of six unit townhomes within the R-1 district through a request for a Planned Development review and recommendation to the City Council.

Modify the R-2 Regulations to allow a maximum of six unit townhomes within the R-2 district reduce minimum lot area from 6000 to 4000 sq. ft. Lot width 50 ft. Front Yard 20 ft. Side Yd. 5 ft. Rear Yd. 10ft. Building footprint shall not exceed 32% of the total lot area. Garden Home / Town Home developments may be permitted without developmental design or departmental review for a six unit development or less. Developments planned for a greater number than six units shall be submitted to the Planning and Zoning Commission for review and recommendation.

Modify the R-3 Regulations to allow a maximum of six unit townhomes within the R-3 district and require developments exceeding six units to be reviewed through a request for a Planned Development review and recommendation to the City Council reduce minimum lot area from 6000 to 4000 sq. ft. Lot width 50 ft. Front Yard 20 ft. Side Yd. 5 ft. Rear Yd. 10ft. Building footprint shall not exceed 40% of the total lot area. Garden Home / Town Home developments may be permitted without developmental design review for a six unit development or less developments in excess of six shall be shall be submitted to the Planning and Zoning Commission for review and recommendation.

Modify the C-2 to expand the residential use 1.a. Existing structures within this district may be repurposed for use as domestic occupancy to permit residential rental property to be developed within existing commercial structures. Rental conversions may be allowed within this district provided all developments for this purpose shall conform to multi-family construction code, life safety code and fire protection requirements for such residential conversions including fire walls, fire escapes, off street parking, occupancy limitations etc. periodic fire inspections. or living facilities within the confines of a commercial structure.

b. All residential conversions or developments located above the first floor shall have an exterior independent means of access from the street level, as well as emergency egress to the exterior of the building terminating at the street level.

Modify the M-1 and M-2 Districts to allow secondary residential use limited to a single story site built or industrial manufactured home not to exceed a living area of one thousand square feet or a residential facility on the ground floor within the confines of an existing structure.

The commission recommended that a property maintenance ordinance be adopted to require minimum standards for commercial buildings.

The commission recommended further consideration of carports modifications.

The commission recommended further review and consideration of adopting additional limitations on billboards.

The commissioners agreed the fascia and façade regulations could improve the windshield perception of the community, however the commissioners felt that such would be excessive regulation as well as additional expense would discourage commercial development and therefor recommended against the adoption.

The commissioners recommended not to adopt any landscaping requirements for the same reasons.

The terms for two of the City of Snyder's appointees, Mr. James Brown and Mr. Jack Gorman, Jr., to the Colorado River Municipal Water District's Board of Directors will expire on May 31, 2017.

Mr. Brown has served on the Board of Directors of CRMWD since May 4, 2006, and currently serves as Chair of the Administration and Audit Committee.

Mr. Gorman has served on the Board of Directors of CRMWD since March 5, 2003. He is currently serving as a member of the Operations and Executive Committees.

As set forth in the District's enabling legislation, the terms and qualifications of the Directors are:

"...in May of each year the governing body of each of the cities in Section 2 of this Act shall appoint two (2) directors for the two-year term beginning on June 1 of that year. Each director shall serve for his term of office as herein provided, and thereafter until his successor shall be appointed and qualified. No person shall be appointed a director unless he resides in and owns taxable property in the city from which he is appointed. No member of a governing body of a city, and no employee of a city shall be appointed as director. Such directors shall subscribe to the Constitutional Oath of office, and each shall give bond for the faithful performance of his duties in the amount of Five Thousand Dollars (\$5,000), the cost of which shall be paid by the District."

The term for the City's two appointees will be from June 1, 2017, through May 31, 2019.
