ITEM VI. NEW BUSINESS:

1. Arx Advantage presentation of Buffalo Courts by Rosedale Corporation to be located west of the intersection of Houston Parkway and College Avenue. – Robbye Meyer with Arx Advantage presented to the council a proposed development of affordable rental housing for senior citizens to be built along the north side of Memorial Way just west of College Avenue. The proposed development would be a \$8 to \$9 million dollar investment and would include 72-units, community building, activity room, and a business center. Several residents who own homes adjacent to the proposed location said they were in favor of the project, but that they had built their homes with the understanding that additional single-family homes would be built there. Several council members were also in favor of the project but not the proposed location.
2. Councilmember Mitch Hickman made the motion to deny Resolution R210201A supporting a proposed Housing Tax Credit Community, Buffalo Courts, to be located west of the intersection of Houston Parkway and College Avenue as captioned below:

A RESOLUTION OF THE CITY OF SNYDER, TEXAS, SUPPORTING A PROPOSED HOUSING TAX CREDIT COMMUNITY, BUFFALO COURTS, TO BE LOCATED WEST OF THE INTERSECTION OF HOUSTON PARKWAY AND COLLEGE AVENUE IN THE CITY OF SNYDER, TEXAS.
