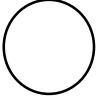

NOTICE

- 1) Two (2) DIGITAL copies and two (2) sets of construction plans and specifications must be submitted by Applicant.
- 2) Work may not start until a permit has been issued pursuant to approval of this application. Permits so issued shall not be construed to alter or set aside any building code requirement, nor shall such issuance of a permit prevent the Building Official from therefore requiring correction of errors in plans or in construction, or of violations of building codes or zoning ordinances.
- 3) Permits shall become invalid if work is not commenced within six (6) months after issuance, or work authorized by such permit is suspended or abandoned for a period of six (6) months or longer after work has commenced.
- 4) Inspections are to be requested as needed during work. A final inspection must be done and a certificate of occupancy issued before a building or structure is occupied.
- 5) Please check your deed restrictions and homeowners Association requirements before building, as they are not regulated by the City.
- 6) I hereby certify that an asbestos survey has been done in accordance with the Texas Asbestos Health Protection Rules (TAHPR) and the National Emissions Standards for Hazardous Air Pollutants (NESHAP) for the area(s) being renovated and/or demolished. DOES NOT APPLY
